Abstract: This article discusses the literary representation of the "concentrationary universe" in works of Yehiel Dinur, the Yiddish and Hebrew author who published under the pseudonym Ka. Tzetnik. He became known to the public on the witness stand of the Eichmann trial in 1962. Ka. Tzetnik's novels Salamandra, Piepel, and House of Dolls are read in this article within the context of the polemic over the Jewish victims' alleged collaboration with the Nazi annihilation system--a polemic generated after World War II by Bruno Bettelheim, Raul Hilberg, Hannah Arendt, and others, and revived by Primo Levi in his last book, *The Drowned and the Saved* (1986). Contrary to previous readings of Ka. Tzetnik's oeuvre, this article presents it as a unique, daring, and nonjudgmental literary testimony to the "inside" of the Lager as a gray zone, a testimony that defies Levi's distinction between "the drowned" and "the saved." Toutefois, en dépit d'une politique officielle visible, la place de la Shoah dans la mémoire collective des sociétés civiles de ces pays est encore limitée. Au sein même de l'ancien bloc de l'Est, les anciennes républiques soviétiques proches de la Russie continuent de célébrer la "Grande Guerre patriotique" et d'occulte plus ou moins le travail de mémoire sur la Shoah. Ce dialogue de sourds entre Europe de l'Ouest et Europe de l'Est est une réalité durable. C'est pourquoi des intellectuels comme Jorge Semprun appellent à la reconnaissance mutuelle des mémoires de la Shoah et du Goulag, base d'une future mémoire européenne. /// This article sheds light on the "Iron Curtain" which divides collective memory in Western Europe and postsocialist Europe. In Western Europe, the extermination of the Jews during World War 2 represents the most abominable crime on the scale of 20th-century horrors, to such an extent that since the end of the 1970s Auschwitz has become a symbol of absolute evil. However, in the former Soviet countries, and especially those who are currently European Union candidate countries, the stress is put above all on the very painful memory of Soviet occupation. Eastern Europeans are critical of the weight given to the memory of the Shoah as they believe that Western Europeans minimize the crimes of communism in relation to the extermination of the Jews. In return, Western Europeans denounce Eastern European anti-Semitism. Under pressure from the European Union, many Eastern European countries have begun a phase of anamnesis. However, in spite of official policy, collective memory of the Shoah among civil society in these countries is still limited. Within the former communist bloc the former Soviet republics which remain close to Russia continue to celebrate the "Great Patriotic War" masking attempts to cultivate collective memory of the Shoah. This dialogue of the deaf between Western and Eastern Europe is a enduring reality. It is for this reason that intellectuals like Jorge Semprun are calling for the establishment of a mutual recognition of memories of both the Shoah and the Gulag throughout Europe which would serve as a basis for a future common European memory.

Abstract: Se presenta en este artículo una reflexión sobre un aspecto de la condición del exilio: la interrelación entre memoria personal y colectiva, a partir de cinco obras singulares y complementarias: Vida en claro (1944), de José Moreno Villa, Otoño en Madrid hacia 1950 (1987), de Juan Benet, Los años sin excusa (1975), de Carlos Barral, Autobiografía de Federico Sánchez (1977), de Jorge Semprún y Travesías (1925-1955) (2003), de Jaime Salinas. Utilizando el concepto de memoria individual y colectiva desarrollado por Paul Ricoeur se discute la difícil combinación de ambas entre los escritores en situación de exilio y dictadura a causa del más difícil funcionamiento de los más mínimos mecanismos que permiten su interacción. A partir de la difícil conciliación entre anécdota individual y experiencia colectiva consiguen estos autores una versión de la historia: ambigua y parcial, de intervención y amago, acentuando así las contradicciones de la autobiografía. El sueño imposible de una memoria total que integrara la individual, la colectiva y la histórica, se revela como más difícil de conseguir para estos memorialistas.
